Message from the CEO



Dear Readers, Greetings!

We are delighted to present you progress highlights as of mid-December 2022 including a success story of our member in Karnali Province and recent capacity building initiatives.

In this issue, we present you the story of Ms. Gita Nepali, our member in Karnali Province who established herself as a successful entrepreneur running a garment industry in Birendranagar Municipality, Surkhet.

The capacity building events in the recent past included over a hundred members and staff including the Centre Mobilizers and Managers/Supervisors. This included an exposure visit by a team of 16 senior staff to Grameen Bank, Bangladesh from 26 November to 01 December 2022.

The disbursement under corporate social responsibility (CSR) and client protection (CP) activities continued during the reporting period. So far in this FY 2079/80, we have provided maternity allowance to 1,044 members (totaling NPR 2,019,600); critical illness relief to 138 members (totaling NPR 1,275,000) and disaster relief to 243 members (totaling NPR 903,000). Likewise, we facilitated settlement of 844 insurance claims of the members amounting to a total of NPR 71,780,799.

Our service coverage and outreach in terms of the number of Centres as well as clients suggested business consolidation during the reporting month. Though the number of Centres and active clients increased marginally, a slight decrease in the number of loan clients was noted as of mid-December 2022. The reporting period was also marked with slight reorganization in the field teams with an outlook of congenial business environment.

Exposure Visit to Grameen Bank, Bangladesh

A team of 16 senior staff from various regional and branch offices visited Grameen Bank, Bangladesh from 26 November to 01 December 2022. The team was exposed to the philosophy and operations of the hosts through one-day briefing at their head office, field visits to the selected branch offices and finally a review at the head office.





Among others, the visiting team learnt on several measures adopted by Grameen Bank in reducing PAR developing effective monitoring and supervision mechanism. The measures included limited loan investment per borrower, frequent inspection on loan utilisation, weekly loan recovery, emphasis on field interaction, and effective auditing.

The number of Centres increased by 49 reaching to a total of 22,486. While the number of active clients increased by 727 reaching to a total of 401,322; the number of loan clients decreased by 1,262 reaching to a total of 237,935. Likewise, the number of staff has dropped by 44.

The loan disbursement reached a volume of NPR 202.69 Billion with an increase of NPR 1.64 Billion during the month. However, savings and deposits stood at NPR 18.43 Billion, same as last.

The selected financial indicators suggested no major movement. The loan disbursement increased marginally yet loan outstanding figure decreased slightly during Marg 2079 (corresponding mid-November to mid-December 2022). The savings & deposits figure stood as last.

During Marg 2079 (corresponding mid-November to mid-December 2022), Nirdhan provided maternity allowance to 230 members (total NPR 453,600) and Critical Illness Relief to 54 members (total NPR 505,000). However, no disaster relief was processed this month. Likewise, it facilitated settlement of 220 insurance claims during the month amounting to a total of NPR 18,270,524.
